



WINTER 2017/2018 PARKING AND TRANSPORTATION INFORMATION

IMPORTANT INFORMATION REGARDING OUR NEW PARKING SYSTEM

- 1) Again this winter, the Town of Snowmass Village will be utilizing our new parking permitting and enforcement system. As last winter the biggest change is that we have done away with physical permits. Your vehicles license plate will now serve as your permit number. No more scraping off the old permits and re-affixing the new ones. Once you have registered your vehicle(s) and paid for your permit(s), your information is in the system and your vehicle is valid for the season. Resident Permit prices will remain unchanged for the 2017/2018 Winter Season. As in years past, Residents will be allowed a maximum of three permits per household. Of the three vehicles that you are allowed to permit, you may **purchase only one of each** of these permit types:
 - 1st Resident Permit = \$60.00
 - 2nd Resident Permit = \$100.00
 - 3rd Resident Permit = \$185.00
 - Resident "R" Permit = \$40.00
- 2) **If you sell your vehicle or for any reason replace your license plate, notify us immediately.**
- 3) This winter to go along with our new permitting system there will also be new parking lot signage designations. Full Resident Permit privileges will now be referred to as "Premium" parking. **Resident 1, 2 and 3 Permits** have "Premium" privileges and as last year, are allowed to park in Village Lots 1 through lower 5, 8 through 13 and The Divide Lot. The **Resident Restricted Permit** has "Restricted" parking privileges and also as last year, may park in Village Lots 10 through 13 only. Look for the new signs at parking lot entrances this season and know which parking lots your vehicle has access privileges to.
- 4) Day skier parking is available in the Base Village parking garage and Two Creeks. Base Lot C is not available this year due to construction. For pricing and information for **Base Village parking call (970) 924-6000**. For pricing and information for **Two Creeks call the Aspen Skiing Company at (970) 923-1220**. **Town of Snowmass Village resident parking permits are not valid in the Base Village parking garage or Two Creeks parking lots.**
- 5) For the winter season there will again be time-restricted parking spaces in lot 6 and upper lot 5. This has been done to make it more convenient for people to access the Mall for short periods. Please be aware of the location and posted time limits of these parking spaces.
- 6) Vehicles may not be stored in any town parking lots. The Snowmass Village Police Department requires all vehicles to be legally registered, permitted, mechanically sound and moved to a plowed parking spot every 7 days or following a snowstorm. Vehicles not moved within 7 days, or following a snowstorm will be subject to ticket and tow.

TRANSPORTATION INFORMATION:

There will be no changes to the Village Shuttle service for the upcoming winter season. Please consult our 2017/2018 route map or call the Transportation office for specific route information.

GENERAL INFORMATION:

- 1) Our Transportation and Parking office is the first office on the left as you enter Elbert Lane.
- 2) We will begin our winter bus service schedule on Thursday, November 23rd.

Dear Snowmass Village resident,

Snowmass Village residents may obtain their parking permits by mail. Please provide all the information requested on the back of this page, and return it together with the required items as listed:

- Pricing is for each individual Resident permit
 - 1st Resident Permit = \$60.00**
 - 2nd Resident Permit = \$100.00**
 - 3rd Resident Permit = \$185.00**
 - Restricted Resident Permit = \$40.00**
(See other side of form for permit details.)

These prices are for each individual permit. Each residential household is allowed a maximum of three permits, out of the four available permit types. If you choose to purchase a Resident 1 permit @ \$60 and a Resident 2 permit @ \$100, the total cost is \$160.

Please send a check for the total cost of all permits made payable to "TOSV".
DO NOT SEND CASH

- **PROOF OF RESIDENCY.** If your name is listed on the county tax rolls as a Snowmass Village property owner as of September 15, 2017, no other proof is required. If your property is not listed in your name, or varies from the name on the parking application for any reason (i.e. listed under a partnership or recently acquired,) please explain and attach copies of ownership evidence, e.g. a partnership agreement.
- **COPY OF CURRENT VEHICLE REGISTRATION(S).** A copy of a current vehicle registration that is in your name **must be attached for each vehicle to be permitted**. In our new permitting system once vehicle ownership has been established it will no longer need to be confirmed annually.
- **A SELF ADDRESSED STAMPED ENVELOPE.** This is no longer required unless you would like your receipt and a confirmation that your vehicle(s) are properly permitted and in the new system mailed to you. Keep in mind that we are no longer issuing physical permits and that your license plate now serves as your valid permit number. **Please take the time to add an e-mail address to your customer information as this can be used in the future in lieu of a self addressed stamped envelope.**

Incomplete applications cannot be processed. Please recognize that, in our dynamic resort community, proof of residence must be verified annually.

I hope that our permit mailing proves convenient for you. You are always welcome to purchase your permit(s) in person at our office. Our office is located on Elbert Ln, in the upper mall level. Please bring the items listed above. If you have any questions please call our office at (970) 923-2543. Your comments or suggestions concerning Snowmass Village's parking or bus systems are always appreciated.

Of the three permits allowed, you may purchase only one of each available type. Note that prices listed are for **each individual permit.**

RESIDENT PERMIT REQUIRMENTS

- 1. NO PERMITTED RESIDENT VEHICLE MAY PARK IN ANY LOT POSTED AS "PRIVATE PARKING", DESIGNED FOR BUSINESS OWNER/MERCHANT PARKING, THE "TWO CREEKS" PARKING LOT OR EXCEED THE POSTED TIMED PARKING RESTRICTIONS.
- 2. **RESIDENT 1, 2 OR 3** PERMITTED VEHICLES MAY PARK IN LOTS DESIGNATED AS "**PREMIUM**" PARKING. THOSE ARE LOTS 1 THROUGH LOWER 5, 8 THROUGH 13 AND THE DIVIDE LOT AT KRABLOONIK.
- 3. **RESIDENT RESTRICTED** PERMITTED VEHICLES MAY PARK IN LOTS DESIGNATED AS "**RESTRICTED**" PARKING. THOSE ARE LOTS 10 THROUGH 13 ONLY.
- 4. IT IS INCUMBENT ON YOU TO KNOW WHICH VEHICLE(S) ARE PERMITTED FOR WHICH PARKING LOTS.
- 5. YOUR LICENSE PLATE SERVES AS YOUR PERMIT VERIFICATION NUMBER. DO NOT CHANGE, TRANSFER OR ALTER IT IN ANY WAY WITHOUT CONTACTING THE TOWN OF SNOWMASS POLICE AND OR PARKING DEPARTMENTS.
- 6. VEHICLES PARKED IN LOTS 1 THROUGH 13 MUST BE MOVED AT LEAST EVERY SEVEN DAYS OR FOLLOWING A SNOWSTORM. VEHICLES NOT IN COMPLIANCE WILL BE SUBJECT TO TICKET AND TOW.
- 7. ANY PERSON PROVEN TO HAVE FALSIFIED INFORMATION ON THE PERMIT APPLICATION OR IMPROPERLY TRANSFERRED A LICENSE PLATE WILL BE SUBJECT TO A \$300.00 FINE AND STATE LAW.
- 8. ALL PERMITTED VEHICLES MUST BE REGISTERED IN COMPLIANCE WITH COLORADO STATE LAW.
